All Food Vendors & Vendors selling, sampling or handing out food products, regardless of whether a fee is charged, **MUST** obtain a One-Day Food Permit from the Northbridge Board of Health (BOH) to participate. The BOH requires that you submit an application for a One-Day Food Permit a minimum of 14 days prior to the event. **ALL Food Vendors must contact the BOH to determine permit requirements, permit fees, and inspection schedules. This permit is separate from the Registration Fees for the WCC Event(s). Anyone without a permit WILL NOT be allowed to participate at the event.**
